Health, Safety and Environment Committee
September 2016 Report

#### **Air and Water Quality**

- Copies of lab results from all but the February Legionella testing – still not received. It has been 2 months since we were told that the administration would release the employee exposure reports to our local union as required by OSHA
- What is the protocol and schedule for future testing?
- Were the utility sinks, boiler tanks and water fountains tested?
- Has there been any advancement made in replacing the sink aerosols with units that do not spray?
- We request that EAP provide team-building training for this joint Safety and Health Committee.
- At least 5 members of USW local 3657 have been tested for legionella to date. The results of those tests are unknown. Members who ask HSE committee members are told that we believe that they might have been exposed to Legionella sero groups 1 and 5.
- GARAGE FUMES: On Tuesday, September
   27, 2016 fumes from painting in the garage

entered the building. There were complaints from the print shop. There were reports of breathing difficulties and burning eyes. One member saw spots. One member went home within twenty minutes. The health and safety committee investigated and discovered the floor in the garage was being painted and cement was being poured. There were complaints of the smell throughout the building and several members had breathing difficulties, sore throats, burning eyes and headaches. Other members reported dizziness. Some members that didn't go home reported feeling chest tightness and sore throats after leaving building. Safety Data Sheets (SDS) were requested. The construction manager provided sheets on urethane primer hardener to the building manager and the health and safety committee got a copy. The garage door was closed during this time so the only way out for the fumes was up into the offices. The main fan in the garage was not to be hooked up until next week. Health and safety was consulted. An email later went out from the International President indicating that there was confusion, the fumes were harmless but people could go home if bothered by the odor. New SDS sheets were requested of Jen Pfeifer to alleviate confusion over harm.

- Our local should have advance notification including Safety Data Sheets (SDS) when potentially toxic or hazardous chemicals are to be applied or used in our workplaces.
- A survey will be circulated to the members to determine how many left work and what impact the cement sealer paint had on them.

#### **ADA Compliance**

- We need to have remainder of the building inspected and evaluated for compliance Floors 3, 5,6(?),7,8,9,10 and 12 were not covered in the inspection of March 2015
- The railing on the temporary accessible ramp is loose.

#### **Garage Renovations**

- There are continued problems with the building ventilation system
- Complaints about dirty air vents causing health problems- need for cleaning. Have the vents been cleaned since our last meeting in March?
- Request for continued air monitoring during renovation/remodeling
- Request updated schedule for completion of project.

# <u>Emergency Preparedness</u>—The list provided to us at the June Joint Safety and Health Meeting was not actually updated; only the date was changed

- Fire and medical emergency procedures need to be updated
- Evacuation Assistance list has not been updated since 2014
- Annual training?
- Need after-hours and weekend procedures, including how to determine that building is empty?

# USW Local 3657 Organizing Committee/Fight Back Pittsburgh

September 2016

- Fight Back Pittsburgh, in partnership with the USW Academic Workers
   Association and United Students Against Sweatshops Local 31, held a very
   successful labor picnic in Schenley Park on September 5<sup>th</sup>. Throughout the
   afternoon about 100 Fight Back Pittsburgh members, students, and academic
   workers came out to enjoy food and fellowship in Schenley Park. The event was
   covered by the Pittsburgh Post-Gazette.
- The fight for an affordable housing fund to combat the rapid trend towards gentrification in many of Pittsburgh's neighborhoods is heating up. On September 19<sup>th</sup>, members of Fight Back Pittsburgh participated in a rally for housing justice in Downtown Pittsburgh and on September 21, Fight Back Pittsburgh members testified at a city council hearing in support of the affordable housing trust fund.
- On September 3<sup>rd</sup>, Fight Back Pittsburgh and other local and national partners will be hosting the Rock Against the TPP at Mr. Smalls in Milvale. The event will be headlined by Anti-Flag and will also feature Anne Feeney, Evan Greer, Ryan Harvey and Sun of Nun. Admission to the event is free but you must RSVP online to reserve your spot. We will circulate RSVP information when it is available.
- Following the Rock Against the TPP, Fight Back Pittsburgh will be hosting a teach-in on the TPP. This teach-in and renewed activism around the TPP comes at an important time as proponents of the trade deal mobilize a push for a lameduck vote.

#### USW Local 3657 Civil Rights Committee Committee Report for September 2016

The Committee met this month and reports the following:

Regarding the USW 17th Annual International Civil Rights Conference, December 5-8, 2016 in Birmingham, Alabama. Doug Ward from Headquarters and Elizabeth Laux from the Field have both been approved and released to attend with lost time and travel.

Regarding the Civil Rights Diversity Report for Local 3657 assigned to a Sub-Committee of the Civil Rights Committee. The Sub-Committee includes Doug Ward, Janet Hill, Julie Lidstone, and Audrey Minor. Doug Ward, Chair, will organize a Sub-Committee meeting and report the groups progress at the 10/12/2016 Civil Rights Committee Meeting. The Diversity Report action item is on-going.

Regarding the Coalition of Labor Union Women's NEB and Educational Conference, November 13–16, 2016. The Civil Rights Committee recommended Elizabeth Laux to attend; however, Elizabeth is attending the USW Civil Rights Conference. Yesenia Alfaro was recommended instead.

Regarding Martin Esquivel Hernandez incarceration. The Committee discussed and agreed that Guillermo Perez would write a letter to President John Lepley recommending LU 3657 do nothing to promote US Attorney David Hickton's visit and event at the USW Headquarters the week of September 19, 2016 as it is a conflict of interest. David Hickton is responsible for the continued incarceration of Martin Esquivel Hernandez and the Civil Rights Committee strongly recommends not supporting Mr. Hickton until he takes positive action in this matter.
