



GREETINGS:

In accordance with Article VI, Section 1 of the Constitution of the International Union, you are hereby notified that the Constitutional Convention of the United Steelworkers will be held in the MGM Grand Marquee Ballroom, Las Vegas, Nevada, from April 10 through April 13, 2017. The opening session will begin at 10:00 a.m., Monday, April 10, 2017.

It is anticipated that the official business of the Convention will conclude by 5:00 p.m. on Thursday, April 13, 2017. Please schedule your travel arrangements to be in attendance until the work of the Convention is completed.

Article VI of the Constitution sets out the rules and procedures for the Convention, including the number of delegates per Local, the eligibility of members to be elected as delegates, the completion of the Credentials, the return of Credentials to the International Secretary-Treasurer, the contest of a delegate's Credentials and the submission of resolutions to the Convention for consideration.

It is important that you refer to your copy of the Constitution of the International Union and make yourself familiar with the rules and procedures found in Article VI. If you do not have a copy of the Constitution, you may obtain one by calling the Local Union Services Department at 412-562-2380.

Enclosed please find the appropriate number of Credentials that your Local Union is entitled to under the provisions of Article VI of the Constitution of the International Union.

An activity fee of \$200.00 for all delegates has been set for this Convention. This fee is also applicable to any Local Union observers. As with fees for District Conferences and other District events such as Education Conferences, the fee will be used to help defray the cost of Convention related souvenirs and a Solidarity Reception which will be held on the first or second night of the Convention. Please be sure that each completed Credential form is accompanied by the correct fee. Checks should be made payable to the United Steelworkers.

In 2005, USLAW initiated a resolution condemning the illegal US military invasion and occupation of Iraq, and calling for immediate withdrawal from Iraq. USLAW affiliates were asked to get their local unions, labor councils, state labor federation and national unions to adopt and forward the resolution for consideration by the AFL-CIO Convention to be held that year. (Only Labor Councils, State Labor Federations and National Unions can submit resolutions to the AFL-CIO convention.)

As a result of USLAW's efforts, more than a dozen resolutions were forwarded to the convention resolutions committee, and with its adoption the AFL-CIO broke a fifty year practice of never criticizing US military operations anywhere in the world.

The next AFL-CIO convention takes place in 2017. This model resolution on Islamophobia provides us with an opportunity to put the AFL-CIO firmly on record against Islamophobia and bigotry directed at Muslims, people from the Middle East and South Asia who have been victims of this form of racist abuse.

MODEL USLAW ISLAMOPHOBIA

RESOLUTION TOWARDS 2017 AFL-CIO

CONVENTION*

Whereas it is in the labor movement's interest to unite to defend our members and all communities from all forms of racism, xenophobia, and other forms of division, as well as violations of civil liberties, unlawful surveillance, and the actions of militarized police forces, and

Whereas Islamophobia (fear of Islam and Muslim people) is not a matter of scattered personal opinions but is an increasingly powerful, dangerous, and structural force in American political and social life that feeds racism, divides our people, and promotes violence and oppression at home and militarism and war abroad, and

Whereas the "War on Terror" has inflamed Islamophobia, involving aggressive unlawful police surveillance and "sting" operations that entrap innocent people, and

Whereas the militarization of our police (transforming police forces into paramilitary units), combined with widespread indiscriminate surveillance, has led to the further estrangement of police from communities of color and the Muslim population of this country they are sworn to protect, and

Whereas the "War on Terror" and militarizing the police have not made us safer, but have caused the police to view the communities in which they operate as 'battlegrounds' and treat their residents as potential combatants, and

Whereas this militarization of police is promoted and abetted by the federal "1033 program," Urban Shield, and other mechanisms that transfer from Department of Defense to police forces, large and small, military supplies ranging from communications equipment to weapons and ammunition to armored vehicles and aircraft, valued in the tens of billions of dollars, therefore be it

Resolved that [name of Local/labor body] calls for the immediate end of the federal "1033 program" and any other means to militarize domestic police forces, and be it further

Resolved that [name of Local/labor body] calls for an end of ethnic and religious profiling, mass surveillance, and "sting" operations in Muslim communities, and be it further

Resolved that [name of Local/labor body] opposes and will confront instances of Islamophobia in our communities, political processes, and among our own ranks, and will act in defense of and in solidarity with victims of Islamophobia, and be it further **Resolved** that a copy of this resolution will be forwarded to our national union, state federation, and Central Labor Council with the request that those bodies adopt it and forward it on for consideration at the 2017 AFL-CIO national convention.

* This language is presented as a template for Locals to consider as they take up opposition to Islamophobia. Locals are free to adjust the specific wording and emphasis. We hope that many Locals will pass the resolution and, as the last "resolved" says, forward it up to higher bodies that have standing to bring resolutions to the AFL-CIO convention (individual Locals do not have standing for that). USW Local 3657 Civil & Human Rights Committee Committee Report for October 2016

The Committee met this month and reports the following:

The Committee discussed and agreed to recommend that the Local cover all related expenses for sending Yesenia Alfaro to the national CLUW educational conference in Las Vegas, November 13th through the 16th. Yesenia is seeking additional financial assistance from her local CLUW chapter in order to reduce the cost to the Local.

A subcommittee of the CHRC formed to produce a diversity report regarding Local 3657's leadership diversity in line with a resolution passed by the Pennsylvania AFL-CIO has also met and is currently collecting the necessary demographic information of the Local's membership. Local 3657 members may be contacted by this subcommittee in order to confirm their demographic information.

The Committee also discussed a project to develop a curriculum on institutional racism and white privilege and hopes to devote time and energy to developing such a curriculum beginning in January of next year.

The Committee also heard a report regarding Pittsburgh LCLAA's annual ¡Que Viva Clemente! celebration of Hispanic Heritage month which was held at the Clemente Museum on Saturday, Sept. 24, 2016, and was made possible, in part, by the generous support of Local 3657. The event raised more than \$10,000 for the non-profit community services organization Casa San José (CSJ). CSJ provides vital services to Pittsburgh's growing Latino community.





USW Local 3657 Organizing Committee/Fight Back Pittsburgh

- Fight Back Pittsburgh, in partnership with the USW Academic Workers
 Association and United Students Against Sweatshops Local 31, held a very
 successful labor picnic in Schenley Park on September 5th. Throughout the
 afternoon about 100 Fight Back Pittsburgh members, students, and academic
 workers came out to enjoy food and fellowship in Schenley Park. The event was
 covered by the Pittsburgh Post-Gazette.
- The fight for an affordable housing fund to combat the rapid trend towards gentrification in many of Pittsburgh's neighborhoods is heating up. On September 19th, members of Fight Back Pittsburgh participated in a rally for housing justice in Downtown Pittsburgh and on September 21, Fight Back Pittsburgh members testified at a city council hearing in support of the affordable housing trust fund.
- On September 3rd, Fight Back Pittsburgh and other local and national partners will be hosting the Rock Against the TPP at Mr. Smalls in Millvale. The event will be headlined by Anti-Flag and will also feature Anne Feeney, Evan Greer, Ryan Harvey and Sun of Nun. Admission to the event is free but you must RSVP online to reserve your spot. We will circulate RSVP information when it is available.
- Following the Rock Against the TPP, Fight Back Pittsburgh will be hosting a teach-in on the TPP. This teach-in and renewed activism around the TPP comes at an important time as proponents of the trade deal mobilize a push for a lameduck vote.
