Local Union 3657 Tellers Committee Recommendations for Online Voting

The USW Local 3657 Tellers Committee submits the following recommendations for online voting on contracts, contract amendments, and other important issues as determined by the Executive Board. The proposed guidelines apply only to elections on contracts and related issues – not officer elections, which are addressed in the By-Laws.

The Tellers Committee recognizes that technology is constantly evolving, therefore these guidelines are meant only to provide a framework for evaluating tools and managing the process.

Recommendation #1: Tellers Committee involvement in online voting

We recommend the Tellers Committee be engaged to conduct all formal online voting processes. All members of the Tellers Committee should be offered administrative access to the system and be involved with verifying membership lists and creating the ballots. The Tellers Committee may appoint a single member of the Tellers Committee to set-up the online system.

If the system offers administrative versus observer status, the Tellers Committee may elect a single administrator from the Tellers Committee while appointing other members as observers. These roles should be noted in the final Tellers Committee report.

Recommendations #2: Choosing a voting system

The Tellers Committee should work with the Executive Board to choose an appropriate vendor for online voting.

Key things to consider when selecting a vendor:

- Affordable
 - In 2019, mail ballots for the contract vote cost \$450 for supplies and mailing plus lost time and travel for one Tellers Committee member to come to Pittsburgh (Approximately \$1,000 for pre and post election travel)
- Compliant with Department of Labor Election Integrity Guidelines
- Clear and secure administrative access levels
- End-to-end verification that a vote has been cast (not how they voted)
- Record retention
- Mobile friendly
- Automatic reminder emails or text messages to membership list sent directly from the vendor
- Accessible training and customer support

Recommendation #3: Voting integrity

The Local Union may use the Communication and Action Team and other approved Local Union communication tools to encourage and remind members to vote. While the Tellers Committee should be able to verify if an individual's vote has been cast, they should not monitor voting while the election is running unless the Tellers Committee determines it is necessary for the administration of the election. Instead, the Local Union should rely on the vendor's tools to send automatic confirmations and reminders.

The Tellers Committee should have a clear understanding of the online system's tools and functionalities to confirm votes cast and authenticate results before the voting process begins.

The Tellers Committee should issue a Tellers Report at the end of the election that notes any issues members had with the system and the impact, if any, on the election results.
